Terms of use

1. General

The users – members of the website www.pizzafan.gr have access to the presentation of our products and services for the purpose of placing orders and promotion thereof.

The user – member is responsible for the access at the services of the www.pizzafan.gr website. The common user is not obliged to fill in the document and the fields in the registration form provided for the members of the www.pizzafan.gr website, in order to navigate the site and see its content. Nevertheless, in order for the user to enjoy the capabilities provided to the users-members, such as the possibility to order on–line, to participate in competitions, to access newsletters, to be informed about and receive promotional material in relation to our products and services, the user must be registered with the services of the www.pizzafan.gr website.

For orders submitted through our website, the following apply: The right to submit an order is attributed to the users of the site who reside in areas served by our stores, unless they chose receipt from the store. No confirmation by the competent department of the Call Center is required.

When you send your order, the following message appears: "Your order has been successfully submitted. You will receive a confirmation email soon". As soon as you receive the confirmation email, your order is already being processed.

• If your total amount exceeds 30€, besides your confirmation e-mail, you will receive a confirmation call as well, at the phone number you stated during your registration.

• In case of potential lack of products, you are going to be informed at the stage of your order's completion.

• No change or cancellation is accepted online after sending the order. You will have to communicate with the competent cancellations-changes department using the tel. nos. 210 811 20 00 and 18 111.

• You can pay by using vouchers (Ticket Restaurant, Hellenic Voucher and Up Hellas/ Cheque Dejeuner), if you have informed us about this on your phone order or on your online order by writing in the additional comments field that you prefer this form of payment.
